#### SYNOPSIS

EVIAN JINGLE Attorney REQUIRED	Evian Jingle is an ordinary suburban civil litigation attorney who is very active in the community and devotes countless hours to soup kitchens and pet shelters. Evian cannot stand it when others use slang and refers to it as a lazy language. Evian is continually bursting with energy and tends to fidget.	Business attire – suit, button-up. BRIGHTEN BIXBY Criminal Psychologist  OPTIONAL	Brighten Bixby is a tough, determined criminal psychologist in the Behavioral Analysis Unit (BAU) of the Federal Bureau of Investigation. Brighten hails from Pinewood Landing, but was transferred to Quantico, the headquarters of the FBI, after becoming an esteemed member of the BAU.	Business casual. COREN OGLETREE Latin Teacher OPTIONAL	Coren Ogletree is a nerdy, socially awkward Latin teacher at Pinewood Landing Junior High. Coren is brutally honest, and this behavior can be off-putting if you're around this teacher too long. Coren has known Miles Randolph since childhood, and anyone close to the family has heard about their big falling out after college. ## **Host Instructions**

The host instructions for both the virtual and face-to-face are included. You can play at home with others, via video-chat, or a combination.

Also, with this game, each player gets a character packet (PDF file) before the game that includes an optional pre-game, a character bio, a suspect list, general instructions, and round 1-2 materials.

The host of the party will have this main game file and access to the solutions for the code challenge and the game.

## EXAMPLE TIMELINE

**7:00 PM:** Guests arrive/log into the video chat. Take guest photos/snapshots and serve refreshments if it is a home party. Home party: have the suspect list available for the guests to view as they trickle into the party.

**7:10 PM:** The host goes over the guests' instructions for the mystery game. It is optional to have each character introduce themselves to the group. You can play the game trailer video as an introduction.

**7:20 PM:** The players are now allowed to view the round one materials (pages 7-8) in their file. The game begins with the investigation of the crime. The mystery investigation sheets are handed out (home party), and the guests interrogate each other. Motives will start to unfold during this round. Miles' 'to-do' list is available for review and discussion.

**7:50 PM:** An optional bonus game is played.

**8:05 PM:** An optional dinner is served &/or the virtual group takes a break together. For a home party, snacks can be served throughout the party instead.

**8:35 PM:** The players are allowed to proceed with the round two materials in their character packets. Home party: the guests mingle about in private/semi-private conversations. Virtual: it's a big group discussion – or, if there is a private chat option, they can make use of that, as well.

**9:05 PM:** The 'to-do' list is decoded.

**9:15 PM:** The forensic report (i.e. fingerprints and the official cause of death/type of poison) is revealed.

**9:30 PM:** The investigation sheets are turned into the host (home party), or the virtual players all show their guesses of whodunit simultaneously.

**9:30 PM:** Dessert and hot cocoa (coffee for adults) may be served at this time for a home party. The host opens the solution file and reads the solution to the game. The players can discuss the crime afterward.

**9:50 PM:** Another optional bonus game may be played &/or host an optional awards ceremony!

To shorten the mystery party, omit the bonus games, don't stop for dinner, omit the accusation round, and don't host an awards ceremony. If you wish to extend the length of the party, add more bonus games!
